- Documents of registration/incorporation/founding statute, and
- Documents detailing shareholding/ membership and
- most recent audited financials, dated no more than twenty-four (24) months prior to the date of application, and
- A letter signed by the chief executive officer or other authorised person declaring:
  - o full compliance with any applicable regulatory provisions and
  - Advising of any current/ pending legal claims against the applicant organization (criminal, statutory, or administrative)
- Two (2) letters of recommendation from:
  - Current members (full/ associate) or
  - Media regulatory body in the applicant's country of registration/operation or
  - Companies Office or equivalent body in the applicant's country of registration/ incorporation

While supporting information for this application may be supplied in the official language of the applicant's country/ territory of registration/ incorporation, the application form is to be completed in English.
